## Manager's Update – June 6, 2024

**Visit with Sen. Kiehl & Rep. Story:** Assemblymember Hanson, Police Chief Reddick, Fire Chief Rauscher, Deputy Manager Deach, and I attended a meeting with Senator Jesse Kiehl and Representative Andi Story on Friday, May 31. We had a great discussion about many topics, including state grant funding for emergency response staffing, equipment, and training programs, the Alaska Court System in Skagway, the future of the school bond debt reimbursement program, rockslide mitigation, ore terminal demolition, and more. As always, Sen. Kiehl and Rep. Story had great information to share, listened to our concerns, and answered our questions. I would like to thank them both for their dedication to their constituents.

**Ore Dock Ribbon Cutting:** The Port of Skagway will host a ribbon cutting ceremony for the new Ore Dock at 6:00 p.m. on Thursday, June 27.

**Tongass Federal Credit Union (FCU):** I received follow-up correspondence from Tongass FCU indicating that they are interested in offering services in Skagway. In order to get something started this summer, they need to know if the Assembly would support a rent-free space on municipal property for two years. Please provide direction to me about if/how the Assembly would like to move forward.

**BRIC Grant:** We recently received an update from FEMA via the State regarding the BRIC Grant for Rockslide Mitigation. Our sub-application was reviewed and approved by the FEMA Region 10 office, and they have forwarded the application on to the Grant Programs Division of FEMA. The Division will now review and finalize the award, barring any additional comments.

**Community Wildfire Defense Grant (CWDG) Program:** The Municipality was informed that it was not awarded a USDA CWDG grant for a borough-wide wildfire protection plan. This application had been submitted on behalf of the Municipality of Skagway and other communities by the Alaska Municipal League. Another round of grant awards will be open for application later this year, and we will consider reapplying at that time.

**Incinerator:** I have spoken with Public Works Director Ames and the incinerator is once again in need of repair. He believes it will be able to operate until the transfer station is online, but then we will need to assess whether to continue repairs or shut the incinerator down. One big concern is the safety of the crew during repairs. I intend to visit the site with Director Ames to assess the MOS's comfort with the safety of the crew during repairs and then bring back a recommendation.

**Library Director's Report:** Summer at the library is in full swing, with visitors and residents alike regularly utilizing our internet services, resources, and collection. Circulation of library materials since May 1st has seen a 13% increase this year since the same time period in 2023! Our Summer Reading Program is in its third week with a great turnout, and we are preparing for our Pride event on Saturday, June 15th, the second annual "Sweets & Stories" at 10:30 am. On the financial and reporting side of things, the end of this month sees both the end of the fiscal year for the Alaska State Library's Public Library Assistance Grant and the deadline for the final report for the

\$20,000 Libraries Transforming Communities grant that we were awarded last year to fund our automatic door.

### **Recreation Director's Report:**

### Senior Programs:

Thanks to Senior Activities Coordinator, Aaron Thompson, senior programs are off to a great start! Beginning in May, the Rec Center began hosting Senior Socials on Tuesdays and Thursdays from 11:30-1:00. Seniors enjoy pastries, games, coffee, and company. Two new senior-assist lounge chairs and a sofa in the multi-purpose room, along with a fresh coat of paint on the walls, make the space even more enjoyable. Socials are seeing an average of 10 seniors in attendance.

Senior Excursions are also underway largely thanks to the generous discounts and donations from several local companies. A dinner at the Skagway Brewing Company kicked off the summer excursions. Last week a ride on the WP&YR railroad provided a leisurely experience. This coming Saturday the seniors are taking the intensity up a notch with an adventure with Skagway Float Tours.

Seniors must be 60 or older to participate in programs. No membership required. Stop by the center or call to be added to our contact list for excursions (or just attend the socials!)

## Youth Programs:

Summer Camp starts next week! A total of 27 local youth entering 3rd-6th grade have registered for day-camps held M-F, June 10-21 & July 8-19. Youth Programs Coordinator, Johanna Evans, has arranged exciting excursions with numerous local companies and entities. The Rec Center will recognize each company this season, but we want to take this opportunity to thank the S.M.A.R.T. Bus as well as the Skagway School who are both donating most of the Camp's transportation needs.

## Facility:

A big thank you to Southeast Alaska Independent Living (SAIL) for donating funds to the Rec Center to purchase 24 youth-sized helmets. The helmets will now be available at all skate parties and available in the skate shack in the winter.

## Staffing:

The Outdoor Recreation Coordinator position was announced with several candidates applying. However, after much discussion between the Rec Director Verhaeghe, Borough Manager Ryan and the Director of Public Works, Tyson Ames, the position will be reannounced. The first announcement indicated this position would oversee municipal trails by 2025. However, the position's priorities must be existing programs in various states of implementation, such as developing the community garden and overseeing the rec center's outdoor spaces (skate park, court/ice rink, playground, field). Although the job description will not be changed, the position will likely not have capacity to oversee the municipal trails maintenance or a trail crew immediately. The coordinator will still have a semi-regular trail presence, but this will first be in the form of leading hikes for locals, trail condition monitoring, and trailhead maintenance (trash/bulletin board). This shift in focus necessitated the position be announced a second time to ensure transparency of duties to those who already applied and fairness to those interested in the updated priorities. Expect to see that announcement later this month.

**Police Chief's Report:** The Police Department was busy over the last month. We are still currently accepting applications for a Police Officer and two Community Service Officers.

I have been in contact with the company that does our door lock controls for the Public Safety Facility; this server is in dire need of an upgrade as it crashes on a regular basis. Fixing this issue is a high priority.

ProComm came to Skagway and installed three of the four repeaters that have been failing at our AB Mountain communications tower. This will fix some of our issues as well as getting the clinic their communications repeater back in operation. While the Goat Lake repeater has not had any issues, we do have a replacement repeater for it that can be installed at any time in the event of a failure. The primary focus was to fix the AB Mountain repeaters.

A communications study was done by REVL and we hope to have the results back from them with a proposal to fix our current communications issues.

Conversations with the Haines Police Department administration is ongoing as we discuss our Dispatch upgrades. If the Zetron equipment is purchased this would give both communities the necessary redundancy needed for either department to handle the communications and dispatching for both locations should an emergency arise or if short staffing is encountered.

The Police department has secured a Well house housing property from H&H with the ability to provide single bedroom housing for temporary use if we find an applicant for any of our vacant positions.

I am still on light duty recovering from shoulder surgery. I have three officers covering all of the shifts. I will do administrative work until I am cleared for full duty.

We have made an arrest on the case with the overdose deaths of Anthony Bowers and James Cook. Jacob Cotton was arrested on Misconduct Involving a Controlled Substance and 2 counts of Manslaughter. He is being held at Lemon Creek Correctional Facility in Juneau on a \$150,000 Dollar bond.



In other news, our most recent hire for dispatch has completed the Public Safety Telecommunicator course and is currently enrolled in the Emergency Medical Dispatcher course, this is a total of 10 weeks' worth of training. These certifications are needed in order to utilize the EMD Guidecards and a bi-annual recertification is done with all dispatchers. All dispatchers are signed up to take the 6-week Fire Communications course offered through APCO International, which is scheduled to start at the end of July. We also partake of required monthly training

through APCO and Police Legal Sciences. Additionally, regular call reviews are done with each dispatcher to ensure that policies and procedures are followed. Information from these reviews is used to identify training needs.

Last week I visited the Haines Police Department Communications Center to get an idea of how they operate. Dispatch Supervisor Clark was gracious in allowing me to sit in and observe their processes. I also learned a fair bit about their phone system Zetron which is what we may switch to here in Skagway. On Friday I will be visiting the Juneau Police Department Communications Center; they recently went through an upgrade of their own, so I am sure there will be lots of information to be shared there.

committee.




