1. Call to Order:

James Canary, Assessor, indicated that the focus this year was on the commercial properties in the historic district. After collecting actual sales information and using the cost approach to derive values, it resulted in a significant increase. There were 36 appeals submitted, most of which were commercial with approximately six or seven residential. For commercial property owners that appealed, he offered to use the income approach as an alternative, but most would not submit their income. Of the ones that did submit income information from 2021 to 2023, he was able to revalue their properties. The result is that all appeals were settled without needing to come before the board of equalization.
