A. Permit Application for Development No. 23-26: Fairway Rentals, LLC., W ½ of Lot 11 Block 2, Request to Alter Building Exterior

Permitting Official Fairbanks was recused.

Applicant Representative Orion Hanson was provided an opportunity to introduce the application to the Commission.

Motion/Second: Hites/Libert that application No. 23-26 is in compliance with Historic District guidelines.

Motion passed by roll call vote, 4 yes, 0 no, 1 absent.

B. Permit Application for Development No. 23-27: Sunbird Properties, LLC., Lot 12 Block 4, Request to Alter Building Exterior

Applicant Representative Heath Goebel was provided an opportunity to introduce the application to the Commission.

Motion/Second: Hites/Wishon that application No. 23-27 is in compliance with Historic District guidelines.

Applicant Representative Heath Goebel indicated that the property owner has conveyed that he is willing to do whatever it takes to be in compliance.

Commissioner Hites indicated that the preferred solution would be to remove the three transom windows that are not above existing windows, and then create the illusion of transom windows above the existing windows with framing.

NPS Liaison Matsov indicated that she would also prefer to see the large side of the building façade be broken up by leaving the existing door trim or wall trim.

Motion passed by roll call vote, 4 yes, 0 no, 1 absent.

C. Building Paint Approval Application No. 23-28: Sunbird Properties, LLC, Lot 12 Block 4, Request to Paint Exterior Walls

Applicant Representative Heath Goebel was provided an opportunity to introduce the application to the Commission.

NPS Liaison Matsov indicated that she would prefer to see the front of the building facing Broadway Street painted the red color in the application, but the part of the building facing 7th Avenue be painted a contrasting color.

Applicant Representative Heath Goebel indicated that he would submit a second application to paint the 7th Avenue portion a contrasting color.

Motion passed by roll call vote, 4 yes, 0 no, 1 absent.

D. Sign Permit Application No. 23-29: Heath & Jaime Goebel, Southeast Tours, N 75' of Lot 7 Block 35, Request to Place a Projecting Sign

Heath Goebel was provided an opportunity to introduce the application to the Commission.

Motion/Second: Libert/Hites that sign application No. 23-29 is in compliance with established historic district guidelines.

The Commission advised the applicant that an acceptable font from the guidelines would need to be used.

G. Permit Application for Development No. 23-32: Duff & Karla Ray, N ½ Lot 1 Block 1, Request to Alter Building Exterior

Karla Ray was provided an opportunity to introduce the application to the Commission.

Motion/Second: Hites/Corrington that application No. 23-32 is in compliance with established historic district guidelines.

Motion passed by roll call vote, 4 yes, 0 no, 1 absent.

H. Sign Permit Application No. 23-33: NPS Klondike Gold Rush National Historical Park, S 30' of E ½ Lot 11 Block 2, Request to Place a Freestanding Sign

Applicant Representative Barry Geersten, Acting Interpretation and Education Manager was provided an opportunity to introduce the application to the Commission.

Motion/Second: Libert/Hites that sign application No. 23-33 is in compliance with established historic district guidelines.

Permitting Official Fairbanks indicated that there is an exemption for temporary signs used for promoting an annual or otherwise periodic or one time event for a nonprofit organization.

I. Sign Permit Application No. 23-34: Jan Wrentmore, Red Onion, Lot 10 Block 34, Request to Place a Projecting Sign

Applicant Representatives Deb Potter and Liz Lavoie were provided an opportunity to introduce the application to the Commission.

Motion/Second: Libert/Hites that sign application No. 23-34 is in compliance with established historic district guidelines.

Applicant Representative Liz Lavoie indicated that one of the photos they have provided shows a single business with two projecting signs from the period of significance.
